5. <u>Faculty of Business (New) Doctor of Medicine/Master of Business Administration (MD/MBA)</u> <u>Combined Degrees Program</u>

Presenters: René Poliquin, Vice-Dean, Faculty of Graduate Studies and Research; and Joan White, Associate Dean, Faculty of Business

Purpose of the Proposal: To offer an MD/MBA Combined Degrees Program (based on the existing MD and MBA programs) to excellent medical students recognizing the value of combining medical studies with advanced management skills and expertise.

Discussion:

Dr White presented the item, noting that the proposal would represent the fifth combined MBA degree offered by the Faculty of Business. The MD/MBA program was developed in recognition of an increasing demand for physicians with management skills and expertise. The combined program would combine the four-year Doctor of Medicine degree with the Master of Business Administration degree and would require five years of study. Upon successful completion of the combined program, graduates would receive both an MBA and MD. There would be no changes to the MD degree requirements other than adding an extra

year to the overall requirements and allowing a break between the pre-clinical and clinical years (between year two and year three) of medical studies to allow the student to complete the requirements for the MBA.

During the ensuing discussion, the presenters addressed questions and comments from members regarding the following matters: the number of courses required; whether an expectation of completion of 42 credits in one year was reasonable; the tuition fees; and the view of the Ministry of Advanced Education and Technology regarding combined degrees in general.

THAT the GFC Academic Standards Committee recommend to the GFC Academic Planning Committee, admission/transfer and academic standing/promotion requirements for a (new) doctor of Medicine/Master of Business Administration (MD/MBA) Combined Degrees Program, as submitted by the Faculty of Business and as set out in Attachment 1 of the documentation, to be effective in 2011.

6. <u>Faculty of Business Changes to Early Admission, Discontinuance of Attendance, Academic Standing/Graduation, Readmission after a Requirement to Withdraw and "With Distinction"</u> <u>Requirements</u>

Purpose of the Proposal: To amend the Bachelor of Commerce Degree Program in the following areas: Early Admission; Discontinuation of Attendance; Academic Standing and Graduation; Satisfactory Standing; Readmission after a Requirement to Withdraw; and "With Distinction".

Discussion:

Dr Geddes introduced the item, noting that most of the proposed changes are for the purpose of providing additional detail or to reflect practice not currently captured in the *Calendar*.

During the ensuing discussion, the presenters addressed questions and comments from members regarding the following matters: clarification regarding permission granted to a student who is discontinuing their program to take academic coursework elsewhere; the right of appeal to the Business Appeals Committee; the credits required to earn "with distinction" and the possibility of attaining the notation without ever having attained a first class standing; and acknowledgement that some students, such as varsity athletes, are unable to manage a full course load.

Purpose of the Proposal: To amend Admission/Transfer Requirements for Post-Secondary Application and Faculty Academic Standing/Graduation Requirements in the Faculty of Arts in the following areas: Applicants who have previously been required to withdraw; Internal Transfer Students; Transfer Students from other Post-Secondary Institutions; Applicants who have been Required to Withdraw Twice; and Academic Standing and Graduation.

Discussion:

The Chair introduced the item, noting that it had been before GFC ASC Subcommittee on Standards (SOS).

Dr Street added that the thoughtful feedback from members of ASC SOS and subsequent consultations led to revisions that strengthened the proposal.

DISCUSSION ITEMS

8. <u>External Programs for Review and Programs in Progress on Campus: Standing Item</u>

Presenters: Kathleen Brough, Portfolio Initiatives Advisor, Office of the Provost and Vice-President (Academic); and Colleen Skidmore, Vice-Provost (Academic) and Chair, GFC ASC

Purpose of the Proposal: For discussion/information.

Discussion:

Ms Brough reported that the Ministry of Advanced Education and Technology had provided the list of degree proposals currently in the system, noting that the list had been distributed earlier to GFC ASC members. She reported that many of the proposals had been reviewed, noting that if members would like an opportunity to review a proposal they should contact her directly. Members affirmed the value of receiving the report and requested that they receive an update as frequently as possible. The Chair agreed to ask the Ministry for quarterly reports and noted that, while the Ministry is looking for means to simplify the process, the length of time it takes for University of Alberta proposals to be reviewed remains a concern.

Ms Brough reported that the University of Lethbridge's Bachelor of Fine Arts (New Media)/Bachelor of Management Combined Degree is now under review.

Regarding Programs in Progress on Campus, Ms Brough reported the following: the Campus Alberta Quality Council has completed their review of the Planning program and the University is awaiting the Minister's formal decision; the PhD in Performance Study, the PhD in Art, Design and Visual Culture, and the PharmD proposals are at the Ministry of Advanced Educated and Technology (AET) for system coordination review; and the Aboriginal Governance Partnership Certificate was returned to the University by AET for the purpose of gathering additional information.

9. <u>Use of SAT Reasoning Test Results and ACT Scores to Fulfill Undergraduate Admission</u> <u>Requirements</u>

Materials before members are contained in the official meeting file.

Presenters: Pat Dalton, Associate Registrar and non-voting member of GFC ASC; and Lihong Yang, Assistant Registrar, International Admissions

Purpose of the Proposal: To incorporate the use of SAT Reasoning Test results and ACT scores as acceptable means of meeting science subject requirements for admission of high school applicants under American based curricula to undergraduate programs.

Discussion:

Ms Dalton introduced the item, noting that the Registrar's Office had looked for efficiencies regarding international admission requirements, while maintaining standards. In 2009, participating Faculties together with the Office of the Registrar undertook a pilot project to provide more options for applicants with American-based curricula results to meet University of Alberta admission requirements.

Ms Yang reported that currently admission for these students depends on equating specific science matriculation subjects to the Alberta system by examining years of study. This does not work well for students under American based curricula as that curriculum generally includes only one full year of study in each of the sciences (biology, physics, and chemistry) which may be taken in grades 9, 10, 11, or 12. The use of SAT Reasoning Test results and ACT scores would allow an alternative method of considering whether or not these applicants had achieved an acceptable level of academic competency and content in required science subjects for eligibility to undergraduate programs.

During the Registrar's pilot project students not meeting the existing science subject requirements were admitted providing the following:

- 1. The student had taken the required science matriculation subject in their US curriculum high school (even if it is one year and even if it was in grade 9) AND,
- 2. The student presented a minimum score of 1100 in the Critical Reading and Mathematics portion (combined) of the SAT Reasoning Test (taken within the same testing date) or ACT with minimum composite score of 26 AND,
- 3. The student met the required admission average based on the average of the five matriculation subjects used for admission purposes.

Since this was a pilot project, the initiative had not been publicized on the University's website or in any recruitment publications. The number of applicants who were aware of the pilot project was limited. For Fall 2009 admission, the Faculties of ALES, Arts, and Science participated and six registered students were admitted. For Fall 2010 admission, all nine direct entry Faculties participated and nine registered students were admitted. The office of the Registrar, together with Faculties, monitored the academic performance of all 15 students. The average AGPA of the students are between 2.3 and 2.4. This is comparable to other students admitted with comparable averages.

During the ensuing discussion, the presenters addressed questions and comments from members regarding the following matters: the make-up of the scores; whether data is available by participating Faculty; concern that the average GPA attained during the pilot project appears low; that SATs have been questioned as fair measure as they tend to favour applicants from particular socio-economic groups, and whether analysis had been done regarding whether the students entering with high SAT scores attained higher GPAs than students with lower SAT scores.

The Chair agreed that the item would come forward to a future meeting of GFC ASC with a report that would include comparative data and analysis of trends.
