5. <u>Proposal for a Master of Business Administration (MBA)/Bachelor of Science (BSc) in Pharmacy</u> <u>Combined Degrees Program – Admission/Transfer and Academic Standing/Graduation</u> <u>Requirements</u>

Purpose of the Proposal: To offer an MBA/BSc in Pharmacy Combined Degrees Program (based on the existing MBA and BSc in Pharmacy programs) to excellent pharmacy students who recognize the value of combining pharmacy studies with advanced management skills and expertise and to develop pharmacists capable of pursuing careers that balance clinical care with managing change in a healthcare environment.

Discussion:

Dean Kehrer introduced the proposal to members, noting there was considerable demand from both students and industry for this combined degrees program. He noted that Shoppers Drug Mart had committed \$200,000 to help fund this initiative. Dr White commented that the MBA/BSc in Pharmacy Combined Degrees program would be identical to the now-approved Doctor of Medicine (MD)/MBA Combined Degrees program that had been considered and formally approved the previous year. The BSc in Pharmacy program would remain unchanged but, after the third year, the students would take a leave to complete 42 credits for the MBA and then return to the Pharmacy program without losing their place. She noted the combined degrees program would have a low enrolment but, nonetheless, it would make the University of Alberta more attractive to prospective students and faculty.

After a question from a member, it was clarified that the 'statement of intent' and the interview determines an applicant's maturity.

6. <u>Proposal for a Master of Coaching (MCoach) Offered by the Faculty of Physical Education and Recreation – Proposed Admission/Transfer Requirements</u>

Purpose of the Proposal: To offer a Master of Coaching (MCoach) degree to students seeking high-quality graduate education in sport coaching and related topic areas and to develop coaches well prepared for careers in the field of advanced and professional sport coaching, primarily at post-secondary institutions and within the amateur sport system.

Discussion:

Dean Mummery introduced the proposal by noting that it is an extension of an existing graduate program (ie, the coaching option within the course-based Master of Arts (MA)) offered by the Faculty of Physical Education and Recreation, with the addition of a compulsory class. The program was described to have around six students per year with extremely-high completion and employment rates. Dr Mummery noted that there is no similar program in Alberta and only a few in Canada; the University of Alberta is already recognized nationally and internationally for leadership in this field, and the implementation of the MCoach degree will contribute to continued recognition in the field.

- 8. Electronic Grades Entry and Approval Process

Presenter: Jonathan Schaeffer, Vice-Provost and Associate Vice-President (Information Technology)

Purpose of the Proposal: For discussion/information.

Discussion:

Dr Schaeffer spoke to the introduction of the new electronic grades entry system, noting this system will be deployed the following term (ie, Winter Term 2012). The grades will be submitted into Bear Tracks, approved, and, after being sent to the Office of the Registrar, will be available to students. Faculty members will have three options with the formatting of the grades: they can see a table, a table and a graphical representation of the grade assignment, or a table, the graphical representation, and plotting of the grades against the generic distributions that have been approved by the University. There is a concern that showing the curved graph may sway instructors to mark 'on the curve', but this will be a decision left to each Faculty.

During the ensuing discussion, Dr Schaeffer addressed questions and comments from members regarding the following matters: the option of sorting students by name or by student number; adding a median and a mean grade reporting option; the impossibility of meeting the diversity of need in every program; concern over when students can finally view their grades but it being entirely in the Faculty's control; in the future, clearly communicating midterm marks so students know if they need to withdraw from a course or courses in which they are experiencing academic difficulty; the estimated time of four hours to complete the grade entry process; and a recommendation to ask students what they would like to see with respect to the reporting of their grades.
