5. Augustana Faculty's Proposed Embedded Credit Certificate in Writing Studies

Presenters: Allen Berger, Dean, Augustana Faculty; Harry Prest, Associate Dean (Academic Programs), Augustana Faculty

Purpose of the Proposal: To establish an embedded certificate entitled Writing Studies open to all students at the Augustana Faculty.

Discussion:

Dr Prest relayed Dr Roxanne Harde's regrets that she was not able to attend the meeting and noted that Dr Harde was integral in originating the concept of this particular certificate program.

Dean Berger introduced the item to members noting that it had been presented to the GFC ASC Subcommittee of Standards (SOS) with helpful feedback and positive reception. He explained that the credential will attest to the student's enhanced writing competency and will aid him/her in the competitive job market where employers have voiced concern over a lack of communication skills from new applicants.

Dr Prest continued that the certificate is available to students with a wide variety of academic backgrounds and stated he was hopeful more participants in various Faculties would consider this program once the

benefits are seen.

During the ensuing discussion, the presenters addressed questions and comments from members including, but not limited to, the following: whether or not a writing intensive course taken at another University of Alberta campus is applicable to this certification; clarification of what is meant by "writing intensiveness;" the nature of allowing transfer students into the program; the manner in which Augustana Faculty would manage course substitutions within the program (which led to some suggested amendments to the proposed *University Calendar* copy associated with this particular certificate program); and the academic means by which students would be admitted to the program.

DISCUSSION ITEMS

6. Office of the Registrar's Fall 2011 High School Early Final Admission (EFA) Pilot – Update and Recommendation to Terminate

Presenters: Lihong Yang, Acting Associate Registrar and Director of Enrolment Management, Office of the Registrar; Deborah Gougeon, Assistant Registrar (National Admissions), Office of the Registrar

Purpose of the Proposal: To present the Office of the Registrar's recommendation to terminate the High School Early Final (EFA) Admission Pilot based on results from the 2010-2011 and 2011-2012 admission cycles. The pilot, for applicants to Fall 2010 and Fall 2011, allowed for earlier final admission decisions to be made for high-achieving students with the goal of improving the conversion rate of top students from admitted to registered. The Office of the Registrar has provided members with a final report and recommendation for discussion.

Discussion:

Ms Gougeon introduced the item to members explaining that the pilot program was intended to capture high-achieving high school students, but was limited to Alberta students with a 90% average or higher. She explained that the number of students captured through this process was very small and, often, the students affected by this initiative already had the intention of attending the University of Alberta. She also noted that there was confusion regarding early admission and early final admission. She added that the termination of the program does not mean that the University will stop in its efforts to continue trying to recruit and register high-achieving students.

During the ensuing discussion, the presenters addressed questions and comments from members including, but not limited to, the following: the narrow definition of the program that may have led to its failure; the complications arising from Grade XII Provincial examinations; a suggestion to consider what competitors are offering students or what they are using to entice students; the importance of engaging with international students; and the difference between the University of Alberta's and the University of British Columbia's policy on revoking final admission offers.

7. <u>University of Alberta Certificates</u>

Presenters: Bill Connor, Vice-Provost (Academic Programs and Instruction) and Chair, GFC Academic Standards Committee; Ada Schmude, Associate Registrar and Director of Records, Office of the Registrar

Purpose of the Proposal: To discuss the issue of offering a range of certificates at the University of Alberta and to receive feedback from members of GFC ASC. A number of questions related to certificate programs have arisen during the course of development of a handbook on certificate programs for which there are no current institutional answers. These questions include: Should the University establish a minimum number of credits for embedded credit certificates? What is the appropriate role for units that are not Faculties or Departments in the administration of embedded credit certificates? Examples include the Office of Sustainability and the Office of International Initiatives in the Faculty of Education. Is there a limit to the number of embedded certificates that a student can acquire in the course of a single degree program? Can one course be applied towards the completion of multiple certificates? Should there be a graduating Grade Point Average (GPA) for certificate programs? When is a certificate considered to be at the undergraduate level? At the graduate level?

Discussion:

Dr Connor introduced the issue to members by encouraging open discussion; he recommended, as well, that a working group be created to discuss in detail and, in turn, provide recommendations to GFC ASC on this issue.

During the ensuing discussion, the presenters addressed questions and comments from members including, but not limited to, the following: the variety of credits required for different certificates and the suggestion that a standard be established and then maintained to preserve the integrity of all certificates; the unique requirements and nature of different certificates; the possibility of creating both minimum and maximum requirements for certificates; the opportunity for certificates to improve a student's chances in a competitive job market; ensuring that the certificate adds something to standard degree programming; the usefulness of the list of questions provided; the application of a single course to multiple certificates; Grade Point Average (GPA) issues surrounding certificate programs (eg, admission/transfer criteria; academic standing/graduation criteria); whether or not there should be a maximum amount of certificates allowed for students pursuing undergraduate degrees; description of additional certificate programs in the Faculty of Medicine and Dentistry and the Faculty of Extension; and the additional workload that could be imposed upon graduate students choosing to pursue a certificate program.

Dr Connor stated he would welcome those GFC ASC members interested in serving on an *ad hoc* working group focussing on these and other issues associated with the offering of certificate programming at the University of Alberta. A number of members noted their interest in serving.
