DISCUSSION ITEMS

6. <u>Proposed Changes to University Calendar Section 23.3 (Attendance)</u>

Materials before members are contained in the official meeting file.

Presenters: Nat Kav, Associate Dean, Faculty of Agricultural, Life and Environmental Sciences; Ada Ness, Associate Registrar (Enrolment Services), Office of the Registrar; Wade King, Advisor, Safe Disclosure and Human Rights

Discussion:

The Chair introduced the item to members, noting that it had been reviewed initially by members of the GFC ASC Subcommittee on Standards (SOS) at the September 5, 2013 meeting.

Dr Kav explained that, in Spring of 2013, a subcommittee was struck among members of GFC ASC to amend the University Calendar to clarify procedure in cases where students were unable to meet their academic requirements due to protected grounds and that he became the administrative lead on this subcommittee after the former lead, Dr Brenda Leskiw (Faculty of Science), stepped aside because of her impending administrative leave. He added that, since this time, there had been extensive consultation around this issue with several groups and that the revisions to the regulations are consistent with those of other Canadian institutions.

During the lengthy discussion surrounding this item, members expressed several comments and questions, including, but not limited to: that the revisions are not clear what the repercussions would be for not following the (revised) procedure; that the words "incapacitating" and "severe," which were in the current Calendar entry but proposed for removal, should remain within the procedure; that it is a lot of work to prepare examinations and that it is too onerous to expect accommodation surrounding every situation that may interfere with students being able to attend exams; concern about the inclusion of the word "mental" in the regulation; concern about the inclusion of the paragraph surrounding the weight of final examinations; that some of the language within the revisions is inconsistent with Canadian law; that the University's General Counsel should be consulted on this issue; that the section on mental and/or physical illness is drafted poorly; that Dr Robin Everall, Associate Dean of Students, should be invited to join discussions regarding these revisions; that the word "illness" refers to both mental and physical illness and does not represent a change in practice; that some changes are meant to be guideposts for students in the event that they require an exam deferral; that the proposed revisions remove ambiguity within the current procedure; that a hyperlink to the section of the University Calendar referring to the manner in which final exams should be weighted should be included in the revisions rather than as an excerpt of that section of the Calendar; that appeal processes differ between Faculties; and that there needs to be legal clarity surrounding the issue of the weight of final examinations as it applies to the duty to accommodate.

Mr King recommended that the University's General Counsel be consulted to ensure that the revisions appropriately reflect the duty to accommodate.

Dr Kav noted that he was motivated to take on administrative leadership of this subcommittee in order to put into place regulations that would serve to protect students and that he would not continue in the role if members did not share this guiding philosophy.

The Chair thanked members for their work on this project and stated that the item would be brought

forward once again to the next GFC ASC meeting.

7. <u>Report from the Working Group on the Use of Text-Matching Software for Detecting Plagiarism in</u> <u>Student Work</u>

Purpose of the Proposal: For information/discussion.

Discussion:

The Chair welcomed Ms Eerkes and Mr Hackett to the meeting.

Ms Eerkes briefed members on the history of the Working Group on the Use of Text-Matching Software for Detecting Plagiarism in Student Work, adding that the 2011 report of the Academic Integrity Task Force recommended that General Faculties Council (GFC) strike such a working group to formally review text-matching software (TMS). She reported that the GFC Campus Law Review Committee (CLRC) had established the group, and the final report is now before members for discussion.

Mr Hackett noted that although the issue is controversial, the report contains useful, current information on the usage and implications of TMS and that the members of the Working Group endeavored to provide comprehensive information to those who may be impacted by TMS, including students and instructors. He reported that members of the University of Alberta community are already bound to adhere to existing policies and laws regarding privacy and that new ones specific to TMS usage are not necessarily warranted.

During the ensuring discussion of this report, members expressed a number of comments and questions in relation to this item, including, but not limited to: concerns about the protection of student work and privacy in relation to TMS usage; concerns about differing jurisdictional privacy legislation in relation to the physical location of TMS databases; concern that TMS companies could profit off of student work; a suggestion to add this to the University Calendar to provide some clarity around TMS usage; that some instructors use their own versions of TMS programs to attempt to detect plagiarism; that recommendation #6 does warrant the creation of a new policy that informs instructors of their obligation to protect student work; that the majority of students do not plagiarize and that the report is balanced in this regard; that instructors should be disclosing their usage of TMS to students; that many people are unaware of the details of the Freedom of Information and Protection of Privacy (FOIPP) Act; a question concerning how best to circulate the contents of this report to the University community; whether using Google as TMS is appropriate; clarification about the length of time papers can be stored in an internal database; clarification about TMS usage data across the University of Alberta; whether any education sessions on TMS usage are currently planned; whether "tip sheets" are available; the necessity to update the University Calendar to prevent adverse situations from occurring; that anything digitized is not private; concerns about the culture of assumed guilt in relation to plagiarism detection; and that it will be extremely difficult to catch some students who possess skills to effectively plagiarize.

The Chair thanked the presenters for their efforts and members for their commentary on this subject.

She noted that the document is not intended to be a replacement for proper contact and consultation with the Office of the Provost and Vice-President (Academic), University Governance, and the Office of the Registrar.

Mr Bodnar noted that the document is located on the University Governance website.

Ms Brough updated members on the new Provincial Government templates for program proposals, adding

that, while they have not been finalized, she is already working with some of the new templates. She reminded members to contact her with any program proposals so that she may appropriately advise which templates to use.
