AITF Scholarships Update

It remains unclear when or how the AITF Scholarships competition might proceed this year.

US International Travel Ban

Thank you to all members of the FGSR community for supporting our response.

Concrete actions taken to date include:

- Numbers: We believe we have roughly 500 students who would be potentially affected.
- Application Fees: FGSR has waived both graduate application fees for applicants listing citizenship in any of the seven affected countries. This change is in production as of 1 February 2017, and will be backdated to when the Executive Order was issued.
- Application deadlines: Since programs set their own deadlines, FGSR has encouraged departments to be as flexible as possible to accommodate students from the affected countries, within reason.
 FGSR stands by to help with paper work-arounds where necessary.
- Travel funding: If students have received travel awards from FGSR that they are no longer eligible to
 use, our intention is to ensure that student travel is supported. We are also providing high-tech rooms
 from which they can participate by distance in conferences.
- Stranded Students: We would like to support students who are displaced from their US universities.
 These students still need to have the appropriate visas, and there is as yet no suggestion from Customs and Immigration Canada that there will be a fast track. We keep working on this angle, with University of Alberta International and other pertinent partners.

• IDP Requirement: The Individual Development Plan needs to be completed within 12 months (Master's) and 18 months (PhD) of the program start date - as the first deadline approaches, departments may be looking for support (FGSR Contact: Deanna Davis)

Question: How long do students have to complete the professional development requirement - do they really have to complete within 12 months of their program start date? Reply/Clarification (D. Davis): Students have to complete their PD hours by the end of their degree, but must complete their Individual Development Plan within 12 months (Master's) and 18 months (PhD) of the program start date.

Question: How would you suggest that students work to have their ideas incorporated into the doctoral microgrants? Reply (H. Zwicker): I would recommend that you contact the Associate Dean (Graduate) within your faculty to see how you can be involved.

6.0 Open Access and the Education & Research Archive: Gerald Beasley (Vice-Provost & Chief Librarian)

ERA (Education and Research Archive) is the name for University of Alberta's Digital Asset Management strategy, which is being developed and supported by the University of Alberta Libraries. ERA's open access content includes the intellectual output of the University and promotes global opportunities for research discovery as well as for archival preservation. ERA current holds approximately 40,000 items. You can find ERA here: https://era.library.ualberta.ca/

ERA also provides an easy and convenient solution for faculty who must deposit their research in an open access repository to meet funding agency requirements. Upload is either self-serve or librarian-supported. For help, contact the ERA HelpDesk: erahelp@ualberta.ca / 780.492.4359.

What should be added to ERA?

Peer reviewed research (for journal articles, you can include the final, post peer-reviewed draft)

Reasons to use ERA:

- You can expect to increase your research impact
- You can meet granting agency requirements for open-access publishing
- It is an alternative to paying fees for open access
- The world would be a better place if we could share our research and if we can access the world's research

Question: Can you include anything you publish? What about a poster? Reply (G. Beasley): We will include any peer-reviewed work in its stable, final form.

Question: Is there metadata that we can mine to capture information about students' research outputs? Reply (G. Beasley): Anyone with a CCID can search the database.

Question: What if my journal says no to putting my paper in the ERA? Reply (G. Beasley): Some publishers see the ERA and other similar projects as competition. You will need to make a value judgement, and decide whether or not to publish in a different journal.

7.0 GSA Monthly Report - Sarah Ficko

The joint letter sent to graduate students from Heather and Sarah on January 31 on behalf of FGSR and the GSA stating support for those affected by the US travel ban was appreciated by the graduate student community.

The "Inquiring Mind Program" held on January 27 was well received. This education-based prevention program addresses mental health in post-secondary students. The GSA will investigate whether or not the program can be hosted again in future, possibly through the University Health Centre.

8.0 Introduction to Workshop

PhDs do not lead students to the careers they once did. All graduate schools in Canada have an ethical obligation to consider this reality, and ask hard questions about the graduate degrees they have put together for students, most of which were devised in a historical moment when the academic job market was robust enough to serve as pre-professorial training.

As you'll have noticed, we are asking these questions at UAlberta. Examples include:

- Expanded PD offerings with the help of the Government of Alberta grant
- Last summer's doctoral curriculum workshop
- The Doctoral Microgrants program
- The university conversation about multi-disciplinary Signature Areas and interdisciplinary graduate programs that support them
- Next meeting's discussion about the data around GS outcomes (specific to UofA)

Today's discussion is about the doctoral dissertation, and how it fits into this context.

The Canadian Association of Graduate Studies struck a working group composed of graduate deans, academics and students from Canadian universities. They put together this discussion document. The discussion document has an excellent bibliography and some definitions (of discovery, integration, application, etc) that will raise questions from some of us.

This is not a decision-making meeting. It is an opportunity to talk with each other about how we are addressing the big questions about doctoral curriculum in 2017, from our own disciplinary perspectives.

After laying out a bit of history, the authors drive the primary issues toward 3 interrelated questions:

- 1. Content: what should a dissertation say or do?
- 2. Form: how should the dissertation say or do what it does?
- 3. Assessment: what criteria, and exercised by whom, would constitute responsible assessment of a new kind of dissertation?

That's what we're going to spend about an hour discussing. Then, when we regroup as a whole, we'll talk about barriers, opportunities and challenges.
